MEETING CALLED TO ORDER

The budget hearing special meeting of the board of directors of the Pateros School District #122-70J was called to order at 5:50 p.m. in Pateros School Library, and via electronic Zoom by Board chairman Chad Miller with roll call of members and declarations of quorum. The pledge of allegiance was recited. Board members in person or connected were Grace Larsen, Erika Scroggie, Diane Hull, and Rick Trocano. Also, in person or connected were Scotti Wiltse, Superintendent, Brandon Rose, Business Managers; and Jessica Simmons, Recording Secretary.

BUDGET HEARING

The public hearing for the 2025-26 school budget was conducted. Brandon Rose explained the budget, enrollment, and reported on Materials, Supplies & Operating Cost Expenditures (MSOC); a state requirement declaring the amount of state funding received, the amount the district proposes to spend on MOSC, and how the difference will be used and how the use will improve student achievement. Then he proceeded to give a high-level overview of the other funds (Capital Projects, Debt Service, Associated Student Body, and Transportation Vehicle Fund).

PUBLIC FORUM

Rick Trocano made a motion to adopt Resolution 2025-343, approval of the 2025-26 Pateros School District Budget, second by Erika Scroggie. Motion carried unanimously.
