LEVY FOR 2018

The board discussed how to proceed with the replacement maintenance and operations levy. Their goal is to be straight forward and clear. They agreed that the best practice was to follow the original plan and run a four year replacement levy under the current funding formula we are now using. This serves us well in two ways; we are doing as we planned fiscally four years ago, and tax payer's levy rates would automatically be adjusted when the state's plans become clear. The board is scheduled to approve a resolution at the November regular meeting.

The board discussed the time needed prepare for a bond. Their desire is to have ample opportunities to explain to the community what the bond would entail and the need to move forward with a capital project.
