REPORT ON LEARNING WALKS AND PROFESSIONAL LEARNING COMMUNITIES

Clara Oborne reported to the board on the work the teachers are doing in Learning Walks and Professional Learning Communities (PLC). Learning Walks allow teachers to observe their peers in the classroom. Data is collected to track school wide growth. PLC allows teachers to meet together in groups to address instructional and student needs. Notes from the meetings are shared between the groups increasing communication and awareness among teachers. These are voluntary activities with almost 100% involvement of the certificated staff. Teachers were commended for doing much of this work on their lunch break.

BOARD INPUT ON PARAMETERS FOR FOUR DAY SCHOOL WEEK

Five school districts in the state of Washington were approved for a four-day school week this year. This idea is being explored for our district. Scotti Wiltse presented information on what a four-day school week could look like and asked the board for input on parameters they would require. If the board is agreeable to this idea; the concept will be taken to the community to see if it is right for us. Ten slots will be open for the 2020-21 school year.

PROCEDURE FOR THREAT ASSESSMENT APPROVED

Greg Goodnight shared the Pateros Threat Assessment Procedure notebooks with the board. The Threat Assessment Plan is now required by the State.
