IVES STREET SURVEY

Kris Erlandsen presented information about the Ives Street survey. The roadway does not sit within the city right of way. The city and district boundaries need to be adjusted to align with where the road is actually situated. Once documentation for the land swap/property line adjustment is received from the city, Greg will consult with our attorney for review and approval before moving forward

FIELD OF DREAMS SURVEY, CONSIDERATION AND OPTIONS

Jord Wilson was to present information on this item, but was ill and unable to attend. Mayor Carlene Anders gave a brief overview of information regarding different cooperatives possibilities.

Kris Erlandsen shared a diagram of the eight acre "Field of Dreams" depicting the placement of baseball and softball fields that was developed by Design West in 2013. He did point out a retaining wall on the edge of the property that would need to be removed to fully utilize the space.

There is a 60 day window to submit rezoning comments to the city planning committee regarding changing the land use from light industrial to public use on the eight acre parcel on Industrial Way. Interested parties are encouraged to send letters to the City of Pateros Planning Committee before the comment time ends.
